3. Minutes of the meeting held on 25<sup>th</sup> January 2008

4. Any Urgent Matters Arising

5. To authorise expenditure on the Horse Riding Route, following a meeting of the HRR Advisory Committee held on 28<sup>th</sup> January 2008 and payments to TD Munday as follows:-

Horse Riding Route expenditure

Cllr. Mrs Oxtoby took members through the following:-

A quotation had been sought from Westcut mowing to cut the grass along the riding route three times per year, to coincide with the existing cutting regime on Northfield at a cost of £15.00 per cut.

Packhams for the sum of £186 + VAT for the supply of a new barrel for the existing padlock and 50 no keys – PROPOSED Cllr. Mrs Oxtoby, SECONDED Cllr. Mrs Brammer and UNANIMOUSLY AGREED.

Membership renewal be charged at £5.00 for the year and new members be charged the sum of £15.00 for the year – PROPOSED Cllr. Mrs Oxtoby, SECONDED Cllr. Brown and UNANIMOUSLY AGREED.

Kent Wool Growers Ltd for the sum of £44.99 + VAT for the supply of 50 no RD3000 'large flag' tags in red and blue, printed with the words 'Northfield Horse Ride' on the reverse – PROPOSED Cllr. Mrs Oxtoby, SECONDED Cllr. Brown and UNANIMOUSLY AGREED.

In order to prevent the necessity for new membership cards to be issued each year, all existing members renewing their membership and all new members, be issued with a membership card that does not include an expiry date – PROPOSED Cllr. Mrs Oxtoby, SECONDED Cllr. Mrs Brammer and UNANIMOUSLY AGREED.

The matter of the provision of an additional entrance, also allowing for disabled access, would be considered by the Northfield Management Committee at their next meeting.
